Statutory you need to provide evidence of the following minimum requirements for acceptance into the ADU:

Junior Member: min. 2 fiction projects (at least 30 working days) in the position applied for + 30 addl. days in a different position*

Full Member: min. 3 fiction projects (at least 30 working days) in the position applied for + 60 addl. days in a different position*

Senior Member: min. 6 fiction projects and min. 400 working days in the position applied for (min. 264 shooting days)

- > Each listed project must have comprised at least 30 working days.
- > *1/3 of the working days *can be* prep days. 2/3 of the working days must be shooting days.
- > Additionally every member must name a direct superior and an ADU member as reference person.
- > If you cannot name an ADU member, a second direct superior must be named.

Obligation to contribute

The members of ADU e.V. (Assistant Directors Union e.V.) pledge to pay a membership fee to the union for the execution of the statutory tasks. Payment is generally in biannual installments, which have to clear in the union's bank account by January 1st and July 1st or paid via standing order (SEPA – direct debit mandate). The first fee is dependent on the number of months to the following biannual payment date and the level of the fee according to the job title. Every other form of contribution payments has to be agreed with the union and confirmed in writing by the ADU.
